## About Ashokrao Mane Ayurvedic Medical College & Hospital

Ashokrao Mane Ayurvedic Medical College & Hospital is located in the prime location at Vathar, Kolhapur District, Maharashtra. It was established by Shri Balasaheb Mane Shikshan Prasarak Mandal, Ambap in 2009 to cater the needs of medical care to the poorest of poor population in the most backward districts Kolhapur and Sangli in Maharashtra and also to generate medical graduates in the downtrodden village students so as to improve the health care facilities even in the remote villages in these districts.

Ashokrao Mane Ayurvedic Medical College & Hospital campus is spread across 21 acres of land, housing 300 beds with separate residential quarters for teaching faculties, non-teaching staff and resident doctors, separate hostel for boys and girl students and for nursing staff

#### Areas of Collaboration

- Month on medical camp in institute will ease to find any disease does it exist in the campus among students in the campus.
- Medical support in the campus.
- Support 01 Doctors and 02 Nurses within the campus Hospital Facility where students can easily reach for any medical urgencies.
- Health card policy to be implemented for students and faculties in future for medical treatments.

## **Financial Provisions**

A specific clause with financial implications treatments are be made within the lowest charges to the students and Faculty members in the institution.

#### Termination/Amendment of MoU

Both the parties will endeavour to resolve disputes arising between them in relation to this MoU by amicable means. If this not be possible because of irreconcilable differences then this MoU may be terminated by mutual consent of the two parties.

Either party may terminate this MoU by written notification signed by the appropriate official of the institution initiating the notice.

A minimum of three months prior notification must be sent to the other party prior to the effective date of termination.

## Responsibilities of Parties

- 1. The two Institutions will:
- a) Conduct programmes like medical camps for student's benefits.
- 2. The aim of the Memorandum of Understanding shall be to achieve a broad balance in the respective contributions and benefits of the collaboration, and this shall be subject to periodic review by both Institutions.
- 3. The students/faculty members follow the code of conduct to maintain the reverential ambience of the respective institutions.
- 4. In the event of cancellation of agreement, the participants in the program at such a time shall be permitted to complete their activities at the host institution in accordance with the terms of this agreement.
- 5. The parties shall mutually agree upon the resources in the form of infrastructure and people in order to achieve the objectives stated in this MOU. Each party shall be responsible for its own costs and expenses arising from its performance under this MOU.

#### Terms of MoU

This agreement will take effect from the date of its signing and shall be valid for FIVE years unless sooner terminated, revoked or modified by mutual written agreement between the parties, and may be extended by mutual written agreement. Either party may terminate the agreement at any time during the term by the provision of one month written notice to the other party.

#### Coordinators

Both Parties/institutes will designate one person each who will have the responsibility for coordination and implementation of this agreement on behalf of their Institute and to submit the reports, if any required by the parties herein.

#### Modification

This MOU or its renewal and the actions taken under it may be reviewed at any time Modifications may be made by mutual agreement and any amendment or extension to the agreement may be formalized by the exchange of letters between the two Institutions

#### Assignment

The Parties herein/the Institutions understand and acknowledge that they shall not assign or otherwise transfer its rights or obligations under the Agreement, in whole or in part, without the prior written consent of the other Institution.

## Indemnity

The Parties herein agree to indemnify each other and to defend and hold harmless the other Party, any and all damages, liabilities, costs, expenses and from any loss or that may surface hereinafter, that the other party may sustain or be put to by reason of any flaw or defect or infirmity or as a result of any act and/or omission to act or in any other manner by the indemnifying party.

## Relationship

The Parties to this MOU are independent and the relationship between the Parties shall be on a principal-to-principal basis. Nothing in this Agreement shall be construed to create a partnership, joint venture, or agency relationship between the Parties. Nothing in this Agreement shall be interpreted or construed as creating or establishing the relationship of employer and employee between one Party and the other Party's personnel.

#### Notice

Any notice or other communication required to be given by one party to the other shall be in writing and addressed to the address given above and shall be sent by registered past acknowledgment due/Courier or to the authorized E-Mail ID of the parties herein
